With the CIA agents case in Chihuahua still unresolved and growing tensions with Washington, the U.S. Department of Justice accused Sinaloa Governor Rubén Rocha Moya and nine current and former officials of operating in coordination with "Los Chapitos," facilitating drug trafficking in exchange for bribes, political protection, and electoral support. The indictment describes a complete institutional machinery: officials who leaked operations, police commanders who protected shipments and released detainees, and even complicity in kidnappings and murders.

The case places President Sheinbaum before one of the most complex dilemmas of her government: cooperating with the United States means validating an action that a wing of Morena reads as unacceptable interference; further straining the bilateral relationship, on the other hand, opens a front of unpredictable consequences at a moment when the USMCA review is just around the corner. The government's first signals point toward buying time: the Attorney General's Office and the Foreign Ministry have flagged the need for more evidence as a condition for a possible extradition — though, as Raymundo Riva Palacio notes, this case demonstrates that Washington is willing to act even without Mexico's cooperation.

On the Chihuahua case, the death of two agents in an unauthorized operation triggered the resignation of prosecutor César Jáuregui, opened federal investigations, and exposed serious failures in coordination between levels of government. Governor Maru Campos refused to appear before the Senate, and President Sheinbaum admitted she tried to contact her without success, revealing an open political rupture. Secretary García Harfuch made clear that Washington has offered no explanation, opening a delicate diplomatic front amid ongoing tensions with Trump over the security agenda. As Carlos Pérez Ricart warns, the fight against drug trafficking unfolds on a terrain of unequal and opaque collaboration, where the presence of U.S. agencies raises permanent questions about sovereignty.

On the internal reshuffling, Sheinbaum accelerated cabinet changes ahead of 2027: Ariadna Montiel leaves Social Welfare to take over Morena's leadership — with Leticia Ramírez as her replacement — while Citlalli Hernández resigned from the Secretariat for Women to operate directly within the party.

On security, the federal government captured Audias Flores Silva, "El Jardinero," one of the men closest to the CJNG's top leadership and the most likely successor to "El Mencho." The operation in Nayarit, carried out without confrontations after months of intelligence work, follows the February strike and configures a sustained offensive against the core of the country's most powerful criminal group, though the question persists of whether these blows structurally weaken the organization or merely open the door to a new internal power struggle.

Finally, the capture in Argentina of Fernando Farías Laguna, a former rear admiral accused of leading a fuel theft and customs smuggling network, has become a legal labyrinth: Mexico has already requested his extradition, but a possible asylum claim and the use of false documentation complicate

the process. Sheinbaum herself admitted she hopes the case does not "become a political issue" with the Milei government — a signal of the fragility in the bilateral relationship.

The United States drops a bomb on "narco-politics" in Sinaloa

The U.S. Department of Justice's indictment of Rubén Rocha Moya and nine current and former officials of his government escalated immediately to the binational level and rattled the Mexican political landscape. The accusation holds that an institutional power network operated in coordination with "Los Chapitos," facilitating drug trafficking toward the United States in exchange for bribes, protection, and political backing. As they say in politics, there are no coincidences: hours before the bomb dropped, Claudia Sheinbaum held the shortest press conference of her administration — wrapping up at 8:25 a.m. and taking no questions on other topics.

Beyond the judicial blow, the case points to something deeper: the alleged capture of state structures by organized crime. According to U.S. authorities, the network secured Rocha's 2021 electoral victory through intimidation, then influenced key appointments within the state government and security forces. The indictment describes a complete machinery: officials who leaked operations, police commanders who protected shipments and released detainees, and even involvement in serious crimes. The scheme allegedly allowed the Sinaloa Cartel to operate with institutional impunity, consolidating trafficking routes — particularly for fentanyl — into the United States. The political impact is immediate. The Mexican government cites a lack of evidence and violations of bilateral agreements, while the opposition demands internal consequences. Meanwhile, the Attorney General's Office has opened an investigation, placing the case in a zone of high diplomatic and political tension, with direct implications for the bilateral relationship and the federal government's security narrative.

⚠️ Chihuahua escalates to crisis: CIA, resignation, and clashes between ruling party and opposition

The Chihuahua case moved from incident to state crisis: the death of two CIA agents in an unauthorized operation triggered the resignation of prosecutor César Jáuregui, opened federal investigations, and exposed serious failures in inter-governmental coordination. The revelation that the U.S. agents were traveling with local authorities without notifying the federal government raised alarms over sovereignty violations, while the security cabinet confirmed they had no permission to operate in Mexico. Amid the scandal, Governor Maru Campos refused to appear before the Senate, and President Claudia Sheinbaum admitted she tried to contact her without success, revealing an open political rupture.

The conflict has already transcended the local level: Secretary Omar García Harfuch maintained that the governor "did not know" about the operation, but also made clear that Washington has provided no explanation — opening a delicate diplomatic front amid ongoing tensions with Donald Trump over the security agenda. The message from the National Palace is unambiguous: international cooperation must be limited to information sharing, not field operations, while Washington's silence and Chihuahua's opacity feed suspicions of a parallel relationship with U.S. agencies. The case not only damages the PAN internally but threatens to escalate into a broader bilateral friction, where the question is no longer what happened in the sierra, but who truly controls security on Mexican territory.

👤 Cabinet in motion: the 2027 election pushes Sheinbaum to reshuffle

Ahead of the 2027 midterm elections, President Claudia Sheinbaum began moving key pieces between her cabinet and Morena under a clear logic: pulling operators out of government to strengthen the party. The most visible change is Ariadna Montiel's departure from Social Welfare — the administration's most powerful social structure — to take over party leadership, with Leticia Ramírez as her replacement. This is joined by Citlalli Hernández's resignation from the Secretariat for Women to operate directly within Morena, and the departure of legal counsel Esthela Damián, who is seeking a candidacy in Guerrero. In parallel, Luisa María Alcalde's move to the Presidential Legal Counsel's office and the redesign of party leadership complete a deep reconfiguration. The pattern is clear: these are not merely administrative adjustments but an anticipated electoral strategy, through which Sheinbaum seeks to control candidacies, alliances, and territorial structures from now. Roberto Lazzeri's arrival at the Washington embassy and the changes at the Foreign Ministry reinforce the external front, while internally a circle of trust is being consolidated to prevent the kind of fractures recently seen within Morena. The underlying message is political: the cabinet is no longer

just a governing instrument but an electoral nursery, a move aimed at securing the midterm succession — albeit at the cost of straining institutional operations and revealing that the priority is no longer only to govern, but to win 2027.

Sheinbaum negotiates agreements to contain the fuel price surge

Facing a global crude oil rebound driven by the Middle East conflict, the government of Claudia Sheinbaum activated a containment strategy based not on decrees but on direct negotiation with gas station operators, banks, and distributors to prevent a fuel price spike at the start of her administration. The result: an agreement capping diesel at 27 pesos per liter — when, according to the president herself, it could have climbed to 35 — while keeping regular gasoline around 24 pesos through tax incentives and cost chain adjustments. More than an energy policy, the move is a political-economic inflation containment operation in which all actors "do their part."

Main agreements reached in recent days: Diesel capped at 27 pesos per liter Regular gasoline contained at around 24 pesos per liter Reduction of bank commission for card payments (interchange fee eliminated) Discount of 1.10 pesos per transaction on transport and logistics vouchers Tax incentives (IEPS) to cushion the international oil price spike Estimated subsidies of 2.5 billion pesos per week to sustain prices Voluntary agreements with gas station operators, with Profeco oversight to monitor compliance

Extradition at risk: Farías Laguna case becomes entangled between Mexico and Argentina

The capture in Argentina of Fernando Farías Laguna, a former rear admiral accused of leading a fuel theft and customs smuggling network, opened a front that goes beyond the judicial: Mexico has already requested his deportation or extradition, but the process has become a legal labyrinth due to his possible asylum claim and the use of false documentation to enter Buenos Aires. Behind the case lies an explosive file — with million-dollar losses to public finances and ties to structures within the Navy — that the government of Claudia Sheinbaum wants to close quickly, but which now depends on the timing and decisions of the Argentine justice system. The problem goes beyond the legal: Sheinbaum herself has admitted she hopes the case does not "become a political issue" with the government of Javier Milei, a signal of the fragility in the bilateral relationship. In a context of ideological distance and prior tensions, any legal margin — such as asylum or prolonged litigation — could be used by Buenos Aires to stretch or condition the handover. What began as an emblematic case of corruption and organized crime thus threatens to become a diplomatic test: whether

Argentina cooperates immediately, or whether political friction ends up slowing or complicating the extradition.

Blow to the CJNG: "El Jardinero" captured, shaking up the succession

The federal government struck again at the heart of the Jalisco New Generation Cartel with the capture of Audias Flores Silva, "El Jardinero," one of the men closest to the criminal leadership and the most likely successor following "El Mencho's" fall. The operation, carried out in Nayarit after months of intelligence work and without confrontations, mobilized hundreds of federal forces and follows the February strike, configuring a sustained offensive against the core of the country's most powerful criminal group. More than isolated actions, the strategy seeks to dismantle the CJNG's chain of command in record time, amid external pressure — particularly from the United States — and the government's need to demonstrate territorial control without foreign intervention. However, the cartel's track record of violent realignments and substitute leaderships keeps the key question open: whether these blows structurally weaken the organization or merely open the door to a new internal power struggle.
